

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.

3. **Quantity and Value of Prizes to be Given Away:** One (1) Winner; Approximate total retail value – \$350
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the “Bills”) and LaNova Wings Inc, 4210 Union Rd Suite A, Cheektowaga, NY 14225
4. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an “Entrant”). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
5. **HOW TO ENTER.** To enter, Entrant must follow the on-screen instructions on the designated post on Buffalo Bills’ Twitter page (twitter.com/buffalobills), during the “Sweepstakes Period” stated in Rule No. 2, and share the post as directed.
