

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an (“Entrant”)) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** SnapDragon Apples Prize Pack Sweepstakes (the “Sweepstakes”)
Sweepstakes Period: Begins 12:01am ET on December 5, 2022 and ends 11:59pm ET on December 8, 2022 (the “Sweepstakes Period”)
Drawing Dates: On or around December 9, 2022
Prize Description: One (1) Buffalo Bills and SnapDragon Apples Yeti branded cooler and One (1) SnapDragon Apples Prize Pack and Apples (prize pack mix to be determined by Sponsor)
Quantity and Value of Prizes to be Given Away: One (1) Winner; Approximate total retail value \$475.00
Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the “Bills”) and Crunch Time Apple Growers d/b/a SnapDragon, 52 Walnut Street, Lockport, NY 14094 (collectively, the “Sponsor”)
3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an “Entrant”). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
4. **HOW TO ENTER.** To enter, Entrant must follow the on-screen instructions on the designated post on Buffalo Bills’ Twitter page (twitter.com/buffalobills), during the Sweepstakes Period and share the post as directed. Entrant must abide by Twitter Rules and Entrants must ensure that their Twitter account’s privacy settings are set to allow Buffalo Bills’ social media accounts to view the entry and communicate with the Entrant. Limit one entry per person, per platform; multiple entries will not increase chances of winning and may result in your entry being filtered out. Enter using only a valid Twitter account held by Entrant. All entries must be received by the Sweepstakes Period deadline stated in Rule No. 2.
